Report from the Secretary-Treasurer

I am pleased to report that our Annual Meetings in Memphis, Tennessee, October 16 - 19, 2003 were very successful. Membership registration (Active Members 170 & Student Members 68) was the highest since 1999. Hotel room nights pick-up (446) exceeded our predictions by 62 percent. Attendance at the banquet (163) was the highest since the founding of MSSA in 1975. Our success resulted from member participation and generous financial assistance from the Department of Sociology, Oklahoma State University, Morehouse Research Institute, Morehouse College, Taylor & Francis, Ltd., and some past presidents of the MSSA.

The Association is in good financial state. Current assets as at January 13, 2003 is \$35,734.29. This amount is held in four accounts:

Capitol City Bank – Certificate of Deposits	\$20,700.90
Capitol City Bank – Operating Fund	\$8,762.92
Capitol City Bank – Reserve Fund	\$4835.47
Spectrum – LA Petty Cash	\$1,435.00

Current assets in 2003 are 26.2 percent higher than in January 2002.

Income generation in 2002 was very good. Total income in 2002 was \$31,315.96 compared with \$26,645.32 in 2001. Total Expenses (\$23,616.00) matched closely estimated projections (\$23,750.00) for the year. Overall, we were able to pay all expenses from current earnings. The Income and Expenditure statement shows a net income of \$7,670.03. This figure includes membership dues for 2003 which were prepaid in 2002.

Membership in MSSA for 2003 is 235. Currently we have 169 Active members, 62 Student members, and 4 Joint members. The current membership level is slightly higher than it was last year, but is still below the 322 in 1999.

Registration at last year's Annual meeting showed much improvement. Only 29 persons listed on the program did not register. The previous year's figure was 89.

Our Annual Meetings will be held at the Radisson Hotel in Baton Rouge, LA., November 5 - 8, 2003. I again appeal to members to pre-register for the event. Membership Renewal 2004 & Meeting Registration form will be mailed later.

(Note that this is an extended deadline from my first call for session organizers.)

Your deadline for contacting the panel/roundtable session organizer is **June 15**. The deadline for panel/roundtable session organizers to submit their completed session reports to me is July 15.

Forum sends condolences to the family and friends of Stanford Morris Lyman who died late Saturday night, March 8, 2003. He was the Eminent Scholar and Distinguished Professor of the Social Sciences at Florida Atlantic University in Boca Raton, having previously served on the faculties at The New School for Social Research, UCSD, University of Nevada, Reno, Sonoma State, and UC Berkeley. He published 16 books and over 150 articles, and was the 1984 winner of the SSSI George Herbert Mead Award for Lifetime Achievement in the tradition of symbolic interaction. His most recent book *Roads to Dystopia* (University of Arkansas 2001) was one of five published in the last decade by Arkansas.

He will be missed by all who knew him.
