III. DISSERTATION SYNOPSIS:

My dissertation took a social constructionist approach in examining the reporting patterns of homicides involving juvenile and adult offenders by the news media (<u>Chicago Tribune</u> and <u>Chicago Sun-Times</u>). Homicide cases reported to the Chicago Police Department from 1992 to 2000 were compared to discursive accounts printed in the papers. I speculated that the media over-reported certain atypical, "newsworthy" cases, such as those that are extraordinarily violent or those that involve very young offenders and victims. In doing so, the news media cause unwarranted fear among those who subscribed to their claims. To test whether or not perceptions were based on the reporting patterns of the media, the spatial distribution of the reporting patterns of homicide was compared to cases reported to the police. While previous research suggests that the news media tend to over-report "newsworthy" cases, very few studies have differentiated between adult and juvenile perpetrators. Furthermore, no study, to my knowledge, has used G.I.S. technology to map out the reporting patterns of the media. The findings indicated that certain atypical characteristics such as the age and race of the victim and the race of the offender were significant predictors of whether or not the case was reported in the

newspapers. Additionally, individuals who received most of their crime-related news from the papers reported significantly higher levels of fear of juvenile crime than those who did not read the newspapers on a regular basis.
